ORDER

In continuation of Ministry of Railways (Railway Board)'s order of even number dated 28.4.2015 notifying the constitution of the 'Technology Mission for Indian Railways' (TMIR) with Mission Office at New Delhi and functioning through the 'Mission Implementation and Coordination Committee' (MICC) for taking up identified railway projects for applied research and use on Indian Railways, sanction of the President is hereby communicated to the following terms and conditions for regulating the engagement of Shri N.S. Vyas, Professor, IIT/Kanpur & Mission Chairman, Co-Chairman and Members of the aforesaid Committee :-

(i) Shri N.S. Vyas, Professor, IIT/Kanpur will be associated on part-time basis as Mission Chairman functioning through the Mission Implementation and Coordination Committee' (MICC).

(ii) **Travelling facilities & allowances** : For journeys in connection with the work of the Committee attached with the 'Technology Mission for Indian Railways(TMIR)', they will be entitled for the 1st Class 'A' Duty Card Pass with permission to travel in 1st AC or 2nd AC including Rajdhani & Shatabdi Expresses (with spouse) as per entitlement of the Railway officers of equivalent status on duty. Similarly, the facility of air journey would be as entitled to the officers of equivalent status on duty. They will be paid TA/DA as admissible to serving Railway officers of equivalent status, in case it is not given by their parent Departments.

(iii) **Road Transport**: They will be entitled to Transport facility as admissible to serving Railway officers of equivalent status for undertaking journeys in connection with the work of the Committee. Alternatively, they will be paid conveyance charges as per the existing instructions at par with the Railway officers of equivalent status for actual use of own car for local journeys. They will be entitled to staff car facility while on tour at outside stations exclusively for work of the Committee.

(iv) **Rest House facility** : They will be entitled to Railway Officers Rest House facility while on tour on the same terms and conditions as for serving railway officers of equivalent status.

(v) **Telephone** : Refund of rental and charges as per rules applicable to serving railway officers of equivalent status shall be arranged. On demand, CUG facility as per the entitlement of the Railway officer of equivalent status will be provided to them in connection with work of the Committee. Besides, Railway/MTNL telephone will also be provided in the office of the Mission Chairman..

(vi) **Secretarial Assistance**: Secretarial Assistance and necessary logistic will be provided by Railway Board within the existing staff strength.



2. The expenditure in regard to the aforesaid Committee and Mission is chargeable to the fund provided for the TMIR i.e. Item No.29- Technology Mission for Indian Railways under the head of Assets-Acquisition, Construction and Replacement of RDSO for the year 2015-16. Any additional requirement for the fund will be made by Civil Engineering Directorate of Railway Board strictly as per actual requirement in consultation with Finance(Expenditure) Directorate.

3. The Railway Officers associated with the Committee and TMIR will be eligible to draw TA/DA as per extant rules.

4. Drawing & disbursing Officer for the above purpose will be Pay & Accounts Officer, Railway Board, Rail Bhavan, New Delhi and Coordinating Directorate with them will be Civil Engineering Directorate of Railway Board.

5. The above terms and conditions as finalized by Civil Engineering Directorate issues with the concurrence of Finance Directorate of the Ministry of Railways.
